

MINUTES OF THE MEETING OF THE PLANNING COMMITTEE HELD ON TUESDAY 2ND AUGUST 2022 IN THE OLD SCHOOL ROOM, MARDEN MEMORIAL HALL, GOUDHURST ROAD, MARDEN COMMENCING AT 7.30PM

062/22 PRESENT:

Cllr Boswell, Gibson, Newton, Robertson, Tippen and Turner (in the chair) were present. Cllr Besant, the Clerk and two members of the public were also in attendance.

063/22 APOLOGIES:

Apologies received from Cllrs Adam and Burton.

064/22 APPROVAL OF PREVIOUS MINUTES:

The minutes of the meeting held on 19th July 2022 were agreed and signed as a true record.

065/22 CLLR INFORMATION

Declarations of Interest

Cllr Tippen declared an interest in item 068/22 (Little Cheveney Farm) as a resident living opposite the proposed site.

066/22 IDENTIFICATION OF ITEMS INVOLVING PUBLIC SPEAKING

The two members of the public informed the meeting that they were in attendance for item 22/503405 and 22/503406 as applicants. They did not wish to speak but would be happy to answer any questions from Cllrs if required.

067/22 PLANNING APPLICATIONS WITHIN MARDEN PARISH

22/503405/FULL – 2 Blue House Cottages, Battle Lane

Erection of a rear conservatory, removal of existing shed and erection of a single storey detached garage and a new fence/hedge – resubmission of 22/501779/FULL Cllrs viewed and discussed this resubmission and raised no objection.

22/503406/LBC – 2 Blue House Cottages, Battle Lane

Listed building consent for the erection of a rear conservatory – resubmission of 22/501780/LBC

In relation to the listed building application Cllrs also raised no objection providing the Conservation Officer was satisfied.

068/22 PLANNING APPLICATIONS OUTSIDE MARDEN PARISH: 22/501335/FULL – Land North of Little Cheveney Farm, Sheephurst Lane, Marden (Collier Street Parish)

Installation of a renewable energy led generating station comprising of ground-mounted solar arrays, associated electricity generation infrastructure and other ancillary equipment comprising of storage containers, access tracks, fencing, gates and CCTV together with the creation of woodland and biodiversity enhancements

Additional information – KCC Highways and other responses to the application.

Cllrs had noted that KCC Highways response indicated a route through the centre of Marden village and although KCC stated that Plain Road was unsuitable Cllrs felt that the proposed route through the centre of the village suggested by KCC Highways was still unsuitable due to the congestion in High Street, Church Green and Goudhurst Road along with bends and single

track in some parts of Marden end of Sheephurst Lane. The Clerk was asked to draft a letter which, once agreed by Cllrs, would be sent to Kent Highways, MBC Planning and County Cllr Parfitt-Reid.
