009/19 PLANNING APPLICATIONS WITHIN MARDEN PARISH 19/500904/FULL – BLUEBELL BARN, MAIDSTONE ROAD

Erection of detached store/garage and change of use from agricultural to residential garden Cllrs viewed the application and had no objection in principle but wished it clarified as to what area of land is for change of use and what purpose the roof windows serve in terms of the proposed store/garage.

19/501889/FULL - POACHERS KEEP, HOWLAND ROAD

Erection of a single store side extension and part first floor, two storey rear extension including rooflights

Listed Building Consent for the erection of a single store side extension and part first floor, two storey rear extension including rooflights

Items 009/19(b) and (c) were discussed together.

After viewing the plans Cllrs felt that this is a disproportionate extension to an already extended dwelling especially at first floor level. Cllrs therefore recommended refusal as the

proposal is of a scale and unsympathetic to the existing listed building and is contrary to MBC Local Plan Policy DM30.

Lawful Development Certificate (Proposed) for erection of 1 detailed outbuilding This application has already been granted by MBC – Cllrs noted

Submission of details to discharge Condition 3 (Materials), Condition 4 Joinery) and Condition 5 (Flat Roof Surfacing) subject to 18/504396/FULL and 18/504397/LBC – noted 19/502092/FULL – 2 BEECHBRIDGE COTTAGES, GOUDHURST ROAD

Demolition of existing timber structure. Erection of part two storey, part single storey side extension with internal alterations

Cllrs viewed application and although Cllrs had reservations about the nature of the proposed extension they concluded that there were no planning grounds to object.

Proposed single storey rear extension, erection of porch and replacement of existing Conservatory

No objection to the porch or existing conservatory replacement however Cllrs had reservations about the single storey extension on the north elevation given the scale of the previous extensions to the original property.
