<u>Proposed front porch, internal alteration and changes to fenestration</u> No objection

# 21/505033/FULL - Wanshurst Green Farm, Battle Lane

Conversion and refurbishment of existing derelict timber framed outbuilding into a new 1 bedroom holiday let, including erection of a single storey front extension (Resubmission of 21/500208/FULL)

Cllrs discussed and reviewed the documents for the new application and on viewing page 10 of the Ecological Appraisal that the wrong site was outlined and on page 11 it showed a plan stating that two "outbuildings were to be converted" and not one as outlined in the description. The attached location plan shows a separate outbuilding and a different outlined site. It was therefore agreed that the Ecological Appraisal did not correspond to this application and plans.

Cllrs also found that the proposal description was incorrect as states "erection of a single storey front extension" but this is not detailed on the submitted plans.

Cllrs are therefore unable to comment until the above has been clarified and the correct information supplied.
