## 103/19 PRESENT

## **104/19 APOLOGIES**

Apologies were received from Cllrs Adam, Mannington and Tippen. Cllr Barker also gave his apologies.

### **105/19 APPROVAL OF PREVIOUS PLANNING COMMITTEE MINUTES**
