365/20 MAIDSTONE BOROUGH COUNCIL LOCAL PLAN

Draft Sustainability Appraisal of Spatial Approaches Document

This document was submitted as an urgent update to the MBC Strategic Planning and Infrastructure Meeting on 9th November 2020.

Site 309 (North of Marden) is not included in the preferred option document nor is the employment site 286. However, responses on all four sites had been submitted to the SPI Committee, Borough and County Councillors and MP.

Cllrs were given the opportunity raise concerns:

- (1) Reading statements in the document many are negative towards Marden;
- (2) Employment ratio is stated as 1:1 how is this calculated?
- (3) Cannot see how MBC are putting their preferred document out to consultation as it is contradicted by this document
- (4) Marden (309) is proposed as 2nd best site with Heathlands being MBC's preferred option
- (5) Some confusion over the breakdown of deliverability and scenarios

Next step for MPC:

- (1) Need to think ahead
- (2) Cllrs to read document and give more thought to response
- (3) Agree at what meeting to finalise response (consultation runs 1st December to 22nd December)

Cllrs Adam and Turner together with the Clerk had a meeting scheduled with a barrister on 24th November and the outcome of this would be reported to the Full Council on the same day.
