## 170/23 PRESENT:

Cllrs Adam, Boswell, Burton, Gibson, Robertson, Tippen and Turner (in the Chair). Cllr Besant and the Clerk were also in attendance.

# 175/23 PLANNING APPLICATIONS WITHIN MARDEN PARISH

### 22/505968/FULL – The Old Station House, Church Green, Marden

Demolition of existing garage and store. Erection of a replacement garage and store with first floor Annexe ancillary to the main dwelling house.

Cllrs viewed the amended plans and raised no objection as it reflects the same proposal as that previously agreed under planning application 20/500485/FULL at which time Cllrs raised no objection.

### 23/500514/NMAMD - Staplehurst Transits, Staplehurst Road, Marden

Replacement and relocation of fuel tank Cllrs raised no objection.

Erection of a single storey side/rear extension. Cllrs raised no objection.

#### Maidstone Borough Council Local Plan

Details on the latest updates regarding the review can be seen on MBC's website. The second stage hearings start in May 2023. The site in Marden will be discussed in week 1 (indicative start date of w/c  $15^{th}$  May). Cllrs discussed as to whether MPC should attend and speak. It was agreed that at this moment in time a verbal representation would not be made as there was nothing more to add to MPC's detailed written representation sent previously.

# MBC Planning and Infrastructure Policy Advisory Committee Meetings

Next meeting 20<sup>th</sup> February 2023. One of the items listed was the Gypsy, Traveller and Showpeople SPG. This was due for consultation from 28<sup>th</sup> February and the Clerk would add to the next Planning Agenda.

### Marden PC Policy Review:

Cllrs viewed, and discussed, the Planning Policies at a working group on 7<sup>th</sup> February. These had been recirculated. Cllrs agreed the amendments, and the planning policies would be put to the March Full Council.

#### **Planning Terms of Reference**

Cllrs consider the Terms of Reference for the Planning Committee. This was agreed and would be put before the March Full Council.

### Marden – Assets of Community Value

Cllrs discussed this at the working group on 7<sup>th</sup> February and at the current time no further amendments would be made.

### Department of Levelling Up, Housing and Communities - NPPF Consultation

Cllr Boswell had circulated NALC draft summary response prior to the meeting and Cllr Besant gave a brief update on what was included. After discussion Cllrs noted the content but did not wish to comment.
