22/503882/FULL - Oakstream Barn, Goudhurst Road, Marden

Erection of a single storey side/rear extension and link

22/503883/LBC - Oakstream Barn, Goudhurst Road, Marden

Listed Building Consent for erection of a single storey side/rear extension and link with associated internal alterations at ground floor level

Cllrs viewed these applications together and recognised that there had been a reduction in size and mass of the proposed extension. Cllrs still felt it was contrary to BE1 of the Marden Neighbourhood Plan and Policies DM1ii, DM4.1 and DM32.2 of the Maidstone Borough Council's Local Plan and detrimental to the fabric, character and setting of a listed building in the open countryside and recommend refusal.

22/504536/LAWPRO – 1 and 2 Summerhill Cottages, Battle Lane, Marden

Lawful Development Certificate for proposed erection of a single storey rear and side extensions at 1 and 2 Summerhill Cottages and erection of a detached garage at 2 Summerhill Cottages

Cllrs noted.

22/504542/FULL - 2 The Lambing Shed, Blue House Farm, Battle Lane, Marden

Change of use of agricultural building to residential annexe with garage and storage ancillary to main dwelling including the erection of a single storey rear and side extension. The application had not demonstrated conformity with the Marden Neighbourhood Plan's policy BE4 with regard to demonstrating whether there are any impacts on wildlife habitats in the vicinity of the site or upon the amenities of neighbouring properties. Therefore, Cllrs recommended refusal. If Officers were minded to approve, Cllrs wish to see the condition that the conversion remains ancillary and for the sole use of 1 Lambing Shed.

Listed Building Consent for the erection of a single storey rear extension with 1 roof light and repairs to existing timber sash windows and doors (Resubmission of 22/501809/LBC) Cllrs raised no objection subject to the Conservation Officer being satisfied with the proposal.
