

MINUTES AGREED AT MEETING HELD ON 12TH MAY 2020 BUT NOT SIGNED

MINUTES OF THE MEETING OF THE MARDEN PARISH COUNCIL EMERGENCY COMMITTEE ON 28TH APRIL 2020 COMMENCING AT 7.30PM

Due to the Coronavirus outbreak all Emergency Committee meetings will be held remotely via Zoom virtual conferencing.

176/20 PRESENT

Cllrs Adam, Barker, Boswell, Brown, Jones, Mannington (in the Chair), Newton, Robertson (arrived late), Stevens, Tippen and Turner were present. The Clerk was also in attendance.

177/20 APOLOGIES

No apologies were received.

178/20 APPROVAL OF PREVIOUS MINUTES

Minutes of the Emergency Committee meeting held on 14th April 2020 were agreed and would be signed at the next available meeting when the Full Council convenes in person.

179/20 COUNCILLOR INFORMATION

Register of Interest

There were no changes to Cllrs Registers of Interest

Declarations of Interest

Cllr Jones declared an interest in item 182/20 as resident living adjacent to the playing field. Cllr Boswell also declared an interest in item 182/20 as resident living adjacent to Southons Field.

Granting of Dispensation

There were no requests for dispensation of any item on this agenda

180/20 IDENTIFICATION OF ITEMS INVOLVING PUBLIC SPEAKING

No members of the public were in attendance.

181/20 CLERK'S REPORT

The Clerk had submitted a report to all Cllrs on the past two weeks. Details included update on CoVid-19 co-ordination, meeting proposals (*to be discussed at end of meeting*) and staff working - Noted

182/20 AMENITIES

Open Spaces

Update on any open space issues (Southons Field, Playing Field or Cemetery) The Clerk had ordered 500 tree tags for Cllr Boswell to commence plotting of Parish Council owned trees.

Cllr Boswell, along with assistance from her husband, had planted 15 small hazel trees in Southons Field along the boundary with Appledown Grange and reported that the wild flower meadow was progressing slowly.

The Clerk reported that the cemetery would be closed on 7th and 19th May due to funerals taking place. Signage would be erected on the relevant days by the caretaker and the Clerk would inform the caretaker, and Cllrs, of any further funerals.

Play Scheme Update: Cllrs agreed to review the situation regarding Summer Play Scheme in July as to whether it will go ahead or not. However, the Clerk asked if Cllrs can look at this

towards the end of May prior to registration forms being made available from 15^{th} June – Noted.

Other

Cllr Adam asked for an item to be placed on the next agenda for Playing Field/Adjacent Open Spaces.

183/20 PLANNING

Due to the current CoVid-19 situation Cllrs had been requested to view the application on the MBC website prior to the meeting.

Planning Applications received for Marden Parish:

Cllrs will discuss applications for Khernfields Farmhouse, Tilden Lane together

20/501112/FULL – Branns Farmhouse, Goudhurst Road

Erection of single storey rear extension

Cllrs raised no objection

20/501474/FULL – Widehurst Farm, Thorn Road

Erection of a two-storey side extension and single storey front extension including insertion of front and rear dormers and internal alterations

On viewing the new proposal Cllrs raised no objection in principle. However, felt it was overlarge compared to the current size of the building. Cllrs felt that the single side extension would be more in keeping with the rest of the property if it had a half hip roof.

20/501498/FULL - 1 Colenso Villas, Goudhurst Road

Erection of a two-storey side and single storey rear extension, including loft conversion and rear dormer

Cllrs, in principle, had no objection to the proposed extending of the property. However, in view of the size of the rear dormer being out of proportion to the rest of the property Cllrs recommended refusal of this application in its current form. Cllrs would be more favourable on a smaller dormer at the rear.

20/501513/FULL – Khernfields Farmhouse, Tilden Lane

Erection of a two-storey side extension

Cllrs raised no objection

20/501531/PNEXT – Khernfields Farmhouse, Tilden Lane

Prior notification for a proposed single storey rear extension which (a) extends by 6 metres beyond the rear wall of the original dwelling; (b) has a maximum height of 3.4 metres from the natural ground level and (c) has a height of 2.4 metres at the eaves from the natural ground level.

Cllrs noted proposals

20/501557/FULL – Wheelbarrow Park Estate, Unit 7 and 10, Pattenden Lane

External alterations to existing buildings and new vehicular entrance to car park Cllrs raised no objection but asked the Clerk to retrieve information regarding previous hours of working. If a condition had been attached to any previous applications regarding hours the Cllrs would want to see the same condition attached.

20/501583/FULL – Khernfields Farmhouse, Tilden Lane

Erection of a detached garage with home office above

Cllrs felt, that when taking all three applications together, it was over development in the countryside contrary to Maidstone Local Plan Policy DM30. The development lies in a very open landscape and the proposal would be visible from PROW KM233, KM232 and from further afield.

Therefore, Cllrs recommended refusal.

VE Day

The Deputy Clerk had sent out information regarding VE Day Celebrations with details of holding "front garden parties". Cllrs raised concerns over the possible implications around social distancing that this may result in and also that a lot of residents did not have gardens. It was therefore suggested that residents would be asked to decorate their houses, windows, doors or front gardens to commemorate VE Day and to hold a party within their own property with those sharing the household if they so wished.

Lucks Way Sub-Group had held a preliminary meeting earlier today and notes of this would be circulated to all Cllrs for discussion at the next Council meeting.

Cllr Adam asked if an agenda item could be added to the next meeting for Marden Highway Improvement Plan.
