<u>Non-material amendment – alteration to roof design of plot 2, with the hipped end of the roof</u> now at the southeast side rather than the northwest side subject to 18/5042346/FULL Noted

#### 21/505842/FULL – The Cowshed, Allingham Farm, Summerhill Road

Conversion of existing dwelling into two dwellings with internal and external alterations including a single storey extension and replacement of existing roof.

Cllrs discussed the application and took account of a small increase to the footprint, the ridge being raised by a relatively small amount more aesthetically pleasing, the property is currently in an existing grouping of properties and the design appears reasonably compliant to MNP B4. Cllrs therefore raised no objection.
