248/20 PRESENT

Cllrs Adam, Mannington, Newton, Robertson and Stevens were in attendance. The Clerk and six members of the public were also in attendance.

249/20 APOLOGIES

Cllrs Brown, Tippen and Turner had given their apologies. Cllr Barker had also sent his apologies.

250/20 APPROVAL OF PREVIOUS PLANNING COMMITTEE MINUTES

The minutes of the previous meeting held on 18th February 2020 were agreed and signed as a true record.

251/20 DECLARATIONS OF INTEREST

There were no declarations of interest.

The Clerk made the meeting aware that application 20/500485/FULL was an application being submitted by Cllr Barker however no Cllr had been lobbied.

252/20 GRANTING OF DISPENSATION

There were no requests for dispensation of any item in these minutes.

253/20 IDENTIFICATION OF ITEMS INVOLVING PUBLIC SPEAKING

Members of the public requested that they be permitted to speak in regard to the Call for Sites responses.

254/20 PLANNING APPLICATIONS WITHIN MARDEN PARISH

20/500362/FULL - The Lodge, Goudhurst Road

Studio/garage conversion and enlargement of existing parking area

Cllrs raised no objection to this application subject to it being a condition that this conversion is an annex to the main dwelling and not used as separate accommodation.

20/500485/FULL - Station House, Church Green

Demolition of existing garage and store, and erection of a replacement garage and store with first floor annexe.

Cllrs raised no objection, in principle, to the proposal to the 1st floor annex. However, Cllrs felt that the ground floor door and windows were too domestic and unnecessary for a garage.
