The order to stop up KM250 was made because it was alleged that the path was not needed for public use. The Footpath Group had made several applications for this path to be added to the definitive map and there is ongoing research into the path. It is premature to issue a closure notice until the issues are fully researched. The Parish Council made such representations and two inspectors decided different outcomes.

Cllr Adam left the room

Cllrs strongly contested KCC's view that Marden Parish Council had misunderstood the first inspector's decision and wish to reiterate their objection to the stopping up order on the grounds that it is premature whilst further evidence is being gathered.
