Village Parking Questionnaire

Thanks so much to those residents who completed and gave your views on the Village Parking questionnaire. The feedback will be analysed and discussed further with Maidstone Borough Council. We will give you an update in the Winter Newsletter. Also in the next Newsletter, the Parish Council hopes to give a comprehensive update on a number of highway issues – issues that we know are of great concern to local residents. Speeding, parking on pavements, parking restrictions and pedestrian crossings are all 'hot' topics and we would like to reassure residents that the Parish Council is being proactive on these issues.

The Parish Council met last year with our County Councillor and Kent Highways over the issue of safely crossing roads in Marden. Councillors discussed how we could overcome this problem and the possibility of installing a pedestrian crossing. Our Parish Clerk is chasing our County Councillor to see if there are any funds available to undertake a feasibility study before Kent Highways make any recommendations. Watch this space!



Speeding in the Village

As a result of a speeding survey undertaken recently in Chainhurst, our County Councillor Paulina Stockell has kindly agreed to fund out of her 'Combined Members Grant pot' enforcing a 40mph speeding limit in this area. Kent Highways are currently working on a suitable scheme and once this is drawn up a consultation will take place with the Parish Council and local residents.

The Parish Council recently held a Speed Watch session, but here's some facts from the Community Speed Watch Kent (CSW) team. In the last four years (2012 to 2015 inclusive):

83% of speeding vehicles generating advice letters from multiple observations did so in the same Speed Watch scheme

86.8% of the vehicles observed speeding once were not

86.8% of the vehicles observed speeding once were not detected again by any CSW scheme in Kent in the next 12 months.

89.8% of speeding vehicles that generated a first advice letter did not generate another from Kent's CSW in the next 12 months.

○ 1.35% of observed speeding vehicles generated a second or subsequent advice letter from Kent's CSW in the next 12 months (98.65% didn't).

○ 5.2% (1 in 19) of vehicles observed speeding were high-end offending (50%+ over the speed limit).

○ 1 in 1,421 (0.07%) vehicles observed speeding once then generated four or more letters in the next 12 months.

Keeping Marden Tidy

The Parish Council arrange a village litter pick every Spring. This year the Marden in Bloom members tidied up and weeded the High Street area for the S&SE in Bloom's judging tour in July whose theme this year is 'Clean and Green'. Since the 'Marden in Bloom' campaign started, there has been a noticeable difference in the village especially the High Street area. Our thanks to those of you who have made a big effort in 'tidying up' your frontages. Let's keep this going and encourage residents and businesses to continue the good work in particular keeping frontages clear of weeds especially brambles — weeds are unsightly. 'Let's keep out village tidy — it's good to do something positive for the Community'.

We would also like to offer special thanks to Elaine Tree and Mr Ali from the Taj of Kent for regularly litter picking in the village. Their efforts do not go unnoticed.

On a separate issue, you may have noticed the unsightly pile of rubbish behind the Playing Field. This is also an area where

teenagers congregate. Mira Martin, our Community Warden, has been trying to tackle the problem and hopefully the area will be cleared by members of the Community Payback scheme. The Parish Council is also investigating the installation of a wildlife camera at the back of the playing field to monitor any anti-social behavior.

Dog Fouling

Once again we need to mention dog fouling. This is a particular problem in the Playing Field. Maidstone Borough Council (MBC) has provided posters which have been placed in the Playing Field in an attempt to encourage responsible dog ownership. We are assured that the MBC Dog Warden does visit Marden and the situation is monitored by the Community Warden. If you see any evidence of dog fouling problems please email the details to

enforcementoperations@maidstone.gov.uk or call 01622 602202. Remember dog fouling is a serious health hazard – it must be stopped!

CCTV/Anti-Social Behaviour

The Mobile CCTV Camera is currently located in the Public Car Park. It is designed to monitor anti-social behavior and hopefully acts as a deterrent. The Parish Council is also looking to install a CCTV camera at Marden Playing Field to monitor any potential anti-social behaviour around the Changing Rooms and Play Area.

If you witness any anti-social behaviour, please call 101 immediately. This will enable PCSO Nicola Morris to provide evidence to the Maidstone Community Safety Unit. However, if the situation is urgent, and you cannot get through on 101, please call either Maidstone Police Station direct on 01622 690690 or 999. There is a vehicle specifically designated to anti-social behaviour which can be sent to Marden if issues are reported. Nicola also constantly monitors activity in various hot spot areas in the village in the evenings.

The Cockpit Play Area

As previously reported, this issue has been 'bubbling' since Spring 2014 when Maidstone Borough Council (MBC) produced a draft Play Area Strategy for the borough and announced the possibility of the closure of The Cockpit Play Area. This area was deemed 'non-strategically important' as it is close to the main Playing Field. The Parish Council has been lobbying to prevent the closure. Similarly the Marden Children's Centre has also been lobbying our MP Helen Grant to prevent its closure. Cllrs Tippen and Boswell, along with our Borough Councillor David Burton and Anna Fisk from the Children's Centre, recently held a further meeting with Helen Grant and Maidstone Borough Council. They explained the importance of The Cockpit Play area to the village — it needs to be kept open. Talks are still ongoing.

Open Space

The Parish Council own and maintain the Playing Field, Southons Field and the Cemetery. The Parish Council has recently taken ownership of the Napoleon Drive play area and we hope to update this area to provide under 5 play equipment. There are also plans to tarmac some of the footpaths. It is hoped this work will be undertaken at the Playing Field, Rookery Path and the entrance to Southons Field this Autumn. We are lucky to have two large open spaces in the Parish – the Playing Field with its new play equipment and Southons Field with its new Play Trail. It's lovely to know that both areas are being enjoyed by many families.

Areas of particular note are the grounds of Rookery Court – absolutely fabulous and the judges were very impressed; Highwood Green's hanging baskets; the Bramley Court area; The Allens; the planters and hanging baskets in the High Street; The Old Market; and the ongoing projects at the Memorial Hall and area outside the Library, to name but a few. We will know how we got on at an Awards Ceremony on the 14th September and will report back in the Winter Newsletter.

Meanwhile we have many plans going forward including projects such as bulb planting, working with businesses in Pattenden Lane etc, working with the school children, Scout Group and Brownies and encouraging residents to grow more bee, butterfly and bat enhancing plants. We also have to continue with fund-raising events to keep the group going. If

Road Names on Development Sites

The Parish Council want to hear your ideas about suitable street names. At Highwood Green, Councillors recommended streets be named after local families who lost members in WW1. Marden Medical Centre

The Care Quality Commission (CQC) recently undertook an inspection of the Marden Medical Centre. In the CQC Report, the 'Care' category was pronounced as outstanding and the 'Safe, Effective, Responsiveness and Well-Led' categories were categorised as good. It was noted that the Medical Centre is "an integral part of the local community and actively promotes the health of the population" and the Patients Reference Group "was highly engaged and empowered by the Practice to improve services". This is a great endorsement and an impressive result for our Medical Centre. This is well deserved. The whole community you serve are very proud and grateful to all of you at Marden Medical Centre.

Flu Immunisation Clinics - Wednesday 21st September and Wednesday 28th September at Marden Medical Centre These will be open clinics, no appointment required, from 2.00-6.30 pm for people with surnames beginning A-L on September 21st & M-Z on September 28th. If you are housebound you will be contacted by late October. Flu vaccination is recommended for everyone aged 65 years and above, also for people of any age with chronic conditions including asthma, diabetes, chronic liver or kidney disease or lowered immunity due to steroids or cancer treatment. Anyone who is the main carer for an elderly or disabled person should also have a flu injection.

UK Power Networks – '105'

On 6th September a new national phone number '105' is being launched by electricity network operators for customers to call should they need to report or get information about a power cut in their area. Key points of note are:

- O Dialling 105 will put customers through to their local electricity network operator the company that manages the cables, power lines and sub-stations that deliver electricity into homes and businesses in their area.
- 105 is just one of the ways customers can contact their electricity network operator. They can also contact them by phone or via their website, and most network operators are on social media too.
- 105 is a free service for people in England, Scotland and
- O You can call 105 if you spot damage to electricity power lines and sub-stations that could put anyone in danger. If there's a serious immediate risk, they should call the emergency services too

Kent Fire & Rescue (KFRS) — Fire Safety Advice

Unfortunately over half of all the fires that KFRS attends start in the kitchen with the majority caused by unattended cooking. In a hectic home it's easy to get diverted for longer than you intended and even forget all about the cooking. Usually the worst that happens is burning your dinner but sadly, as KFRS knows only too well, unattended cooking can lead to a serious fire that could result in severe damage to your home and may put you and your family at risk. Make fire safety your main ingredient and help prevent a kitchen fire in your home by following these tips:

- Keep an eye on your cooking and remember to switch off your cooker if you have to leave the room.
- O Use a timer for items placed in your oven or grill to remind when your food is done and to save it from burning.
- O Plan and Prepare if you know you have a busy week ahead, try and plan in advance and prepare meals that do not require lots of cooking.
- O Avoid storing or placing household items on your cooker or stove.
- Keep your cooker, grill and oven clean to avoid a build-up of

grease and fat that could start a fire.

- Keep children and pets well away from your cooking area.
- Ensure electric cookers, toasters and microwaves are turned off at the mains when you have finished using them.
- Fit a working smoke alarm on each floor of your home and test it weekly to ensure it provides early warning in the event of a fire.

Local Heroes!

Andy Wardley is our Crew Manager at Kent Fire & Rescue Service in Marden where there are 8 Fire Fighters. They not only respond to fires, but deal with a range of emergencies including rescue operations, road crashes, collapsed buildings and floods. The Firefighters have also been trained as co-responders, part of a scheme run by Kent Fire & Rescue Service (KFRS) and South East Coast Ambulance Service NHS Foundation Trust (SECamb) together with several Fire Fighters now being Speed Watch volunteers.

As well as answering calls to a range of emergencies, firefighters are trained to co-respond, answer certain life-threatening medical emergencies through the scheme, such as chest pains, heart attacks and breathing problems. As they respond in the local area where they live and work, they are able to attend the scene of an emergency within a few minutes and often before the emergency service arrives increasing the patient's chances of survival. As part of this partnership, Marden firefighters volunteered to extend their existing first-aid training in the use of equipment, such as automated external defibrillators (AEDs). They also carry oxygen and are trained in life-support skills.

The crew also regularly volunteer their time to attend local events, work on projects like helping to install the air raid siren and Pluto pipe line for the History group. The crew also like to take part in local charity events, such as the 'Dandelion Rowathon' where the crew rowed in breathing apparatus and full fire-fighting gear clocking up over 20 miles and raising over £200 for the charity. So thanks Andy and your team for doing such an amazing job in our Parish – you are very special 'Local Heroes'! Amended Nu-Venture Bus timetables have recently been introduced primarily to improve reliability in the light of currently-experienced road traffic and congestion. In general the level of service provided will not be reduced.

- No 26 Maidstone/Tovil/Yalding/Marden/Goudhurst revised timetable on Mon-Sat especially affecting the existing 14:07 service from Maidstone which now runs at 13:37
- No 26A Maidstone/Tovil/Chainhurst new Schoolday service from 5 Sept replacing part of No 28
- No 27 Maidstone/Marden/Goudhurst substantially revised timetable on Mon-Sat
- O No 28 Maidstone/Marden/Chainhurst Schoolday service



from 5 Sept. Bus 26A will now serve the Pattenden Lane/ Chainhurst area replacing Bus 28 there. Bus 28 will run between Marden Station/Library and Maidstone. 
