After viewing the plans Cllrs recommended refusal on the grounds that it was harmful to the setting of the listed building, harmful to the character of the listed building, it is contrary to the principle of extending on an already converted agricultural building and is contrary to Policy DM36 of Maidstone Borough Draft Local Plan.
