Maidstone Borough Council (MBC) Local Plan Review Regulation 22

All major modifications at Regulation 19 were agreed by MBC who submitted its Local Plan Review together with supporting documents to the Secretary of State for Levelling Up, Housing & Communities on 31st March for independent examination. All documentation can be viewed on MBC's website:

Land Adjacent to Albion Road and Copper Lane

As many of you are aware, the draft Local Plan Review Regulation 19 allocated a further development site of 113 dwellings for Marden at land adjacent to Albion Road and Copper Lane.

Marden Parish Council responded to the MBC Local Plan Review Regulation 19 in December 2021 and we had raised various concerns about this site in our Regulation 18b feedback in December 2020. Whilst some of our concerns have been taken on board by MBC in the latest draft, we still have a number of reservations.

However, the matter is now out of both ours and MBC's hands and we wait to see what the Government Inspector has to say later in the year.

"A Vision for Marden 2037" - Marden Neighbourhood Plan (MNP) Review

As part of the ongoing process of neighbourhood plans, the Marden Neighbourhood Plan was adopted in February 2020 following several consultations with residents and Maidstone Borough Council (MBC).

This now forms a legal document and is part of the planning policies within MBC. Due to the review of the Maidstone Local Plan, the Steering Group agreed it was time to review the MNP.

To kickstart the process, the Parish Council held an Open Day on Saturday 7th May "A Vision for Marden 2037" and many thanks to those residents who attended and gave feedback on the existing policies and made other suggestions. We are in the process of reviewing your feedback and analysing your responses and will then start to identify themes and changes to the MNP. Residents who were unable to attend the event also had an opportunity to give feedback online which closed at the end of May. If you would like to be part of this MNP Steering Group, please let Ali know: clerk@mardenkent-pc.gov.uk as we'd like as much input as possible from residents.

The Parish Council is aiming to send a draft pre-submission to MBC for their comments prior to a Regulation 14 Public Consultation in November and hope to submit a revised version to MBC early in 2023. You can find the documentation on our website:

Land at Maidstone Road, Marden – 22/501275/FULL

The Parish Council as well as residents discussed this application on 17th May for the erection of 39 bungalows for the over 55's, a communal hub, communal garden, footpath to Marden Cricket and Hockey Club and associated access and landscaping.

After extensive discussion, Councillors unanimously voted for refusal of this application as it does not conform to Maidstone Borough Council's (MBC) Local Plan and various Marden Parish Council's Neighbourhood Plan policies specifically as the proposed site is outside the village envelope. If MBC are minded to approve the application, Councillors have requested it be called into MBC Planning Committee. You can find our response at: https://bit.ly/ExFullCouncilMin17052022

Reed Court Farm Proposed Chicken Farm - 20/50571

This complex planning application is for the erection of a new free-range egg farm consisting of 3 hen houses and extensive outdoor ranges and fencing, formal vehicle access from Hunton Road and associated parking, landscaping, woodland and tree planting, drainage and other associated works. In April 2020 the Parish Council recommended refusal and Maidstone Borough Council requested further information pursuant to Regulation 25 of the Town & Country Planning (Environmental

Impact Assessment) including a flood risk sequential test and a quantification of the biodiversity net gain which should now be 10%.

Additional Information was received

from the applicant's agents regarding Regulation 25 in February 2022 and Councillors discussed at a Planning Meeting to ascertain whether any of the information received had answered any of our previous concerns. Councillors agreed that the new information did not alter our view and continued to recommend refusal and wished to see this application go to MBC Planning Committee. Planning Applications and Planning Enforcement

Marden Parish Council (MPC) is notified on all applications for outline or full planning permission, listed building consent and advertising consent within the parish. Most planning decisions are made under 'delegated powers' which means that decisions are made by the Maidstone Borough Council professional planning officers. However, there are some applications, especially controversial ones, where the decision needs to be made by the relevant MBC Planning Committee. The committee comprises elected Borough Councillors who may accept, modify, or reject the recommendations made by the Planning Officer.

It is important to note that Marden
Parish Council makes
recommendations to the relevant
planning officer only and does not
determine any planning applications the final decision to grant or refuse
planning applications rests with the
Local Planning Authority - MBC.

The Parish Council can also make representations on other planning issues where it is not formally consulted e.g. enforcement action. We understand some residents may be reluctant to report planning issues and the Parish Council is happy to pursue on your behalf. If you feel there has been an issue with a planning consent, please obtain the site address and nature of the alleged unauthorised works/operations. 

Festive Christmas Lighting

As reported in the last Newsletter, the Parish Council along with many residents were less than impressed with the Christmas lights supplied to us in 2021. Luckily, we were not charged for the lighting, only for the electrical sockets – they certainly weren't what we had expected.

Unfortunately, the style of light columns/lamp posts in Marden would not permit motifs due to weight and being too low to the highway.

Therefore, we have obtained quotes which fit our budget for column wraps. Two options were put out to public consultation at the Open Day in May, by paper at the Marden Library and via an online consultation for residents to choose which option they liked most. This closed on 31st May and it was close. Residents have chosen Option 1 which is pictured below.



Given the constraints of where we can put Christmas Lights in the village, we hope to have a more sparkling display this year.

Infrastructure Spend Plan (ISP/Parish Wishlist

Thanks to all those residents who completed the survey where we asked you to rank your responses into a top six priority list from multiple options. The top six wishes were:

1.Additional car parking in the village centre for village services - we all know about the parking pressures in the village which are exacerbated by commuter parking. The Parish Council are continually trying to source where additional space could be available, but unless a pocket of privately owned land can be made available, this is not feasible in the short term.

- 2.Publicly accessible woodland areas this is probably not achievable as all the woodland is in private ownership.
- 3.Dedicated building for young people including uniformed organisations and youth club this is included on our 'wish list'. The source of funding would need to be from CIL money raised from development.
- 4.New enlarged pavilion at Southons Field with facilities such as utilities & public toilets this has been on the Parish Council 'Wish List' for several years and is a high priority. Funding would need to be from CIL and MPC funds.
- 5.Skateboard/Bike Park the Parish Council has been exploring the

possibility of a Skate Park for some while. It needs to be away from residents so is not feasible on the MPC Open Spaces, and unless a piece of land on the edge of the village could be made available, it is unlikely to happen.

6.Additional Litter Bins – The Parish Council has been liaising with MBC on the possibility of additional litter bins and is a high priority item on the 'Wish List'.

You will have noticed there is a new flower bed bordering the new slabbed area next to the Library and Cllrs Kate Tippen & Anne Boswell planted up on a freezing blustery day back in March. We are delighted to complete the final stage of this project and hope residents agree that it does look so much better and safer.

Allotments & Dementia Garden Update

The Parish Council understands the importance of allotments from a health & wellbeing perspective, and we recognise residents' frustrations at not being able to start using their plots and the Marden Dementia Group not being able to create the dementia garden.

The Parish Council has continued to liaise with Redrow about the allotment site at Highwood Green and negotiations were curtailed during the pandemic. Redrow has been determined that the Parish Council take on the parking spaces adjacent to the site as well as the allotments and we have made it clear to them we do not want responsibility for the parking spaces.

Early in May Redrow confirmed that only the allotment land would now be transferred to the Parish Council, but a few days later a subsequent email was received stating that we would be expected to undertake ownership of the car parking areas in accordance with planning obligations Once again, we told Redrow we would only take on the allotment site and reiterated to them that MPC has no planning obligiations relating to this site. Once we achieve an outcome that is satisfactory to the Parish Council, the Allotment Association, and the residents of Highwood Green. we will let residents know.

Finger Posts & Street Furniture

After extensive investigation, the Parish Council has finally received an acceptable quote to refurbish the fingers and roundels from the three cast iron posts at Howland Road/Battle Lane junction, in the High Street and junction of Plain/Thorn Road and a new wooden fingerpost at Sheephurst Lane/Goudhurst Road junction. They will be removed and reinstalled after work has been undertaken and then the repainting of the posts will be carried out in situ.

We are hoping the Community
Payback Team will repaint the
unsightly bollards at the junction of
the High Street/Maidstone Road
which need refurbishing. If you feel
there is any street furniture that needs
renovating, please let Ali the Parish
Clerk know.



Local Needs Housing Survey

Marden Parish Council is working with Maidstone Borough Council to assess whether there might be a need for "local needs" housing in the parish so that residents who cannot afford to buy or rent locally, are not forced to move away.

It also helps those who have already had to move away make a return to their family support networks and contribute to the local community. To identify whether a need for this type of housing exists in our community, a Housing Needs Survey will be delivered to every household during late June and July. Please do look out for it: we would like to hear from as many residents as possible. The survey will also ask older residents of the parish who might need to downsize or move to more suitable housing to respond, whether they need affordable housing or housing to buy on the open market.

HIGHWAYS & PUBLIC TRANSPORT

Parish Council Highways Improvement Plan (HIP) Update

Highways issues continue to be a cause for concern for residents and the Highways Improvement Plan (HIP) that the Parish Council has developed currently has 28 outstanding items on it. Whilst Kent Highways are supportive, lack of funding means it is doubtful that many of the identified issues will be resolved soon. The Parish Council will continue to push for funding to get some of the key issues dealt with.

Thanks to all those residents who responded to the recent survey on your priorities and the top five issues have been added to the HIP document. We have been liaising with Kent Highways and we are pleased to

advise that the following actions are currently being undertaken.

Because of parking issues at the High Street/Albion Road junction, Kent Highways have extended the double yellow lines beyond the lay by in front of the Chemist area. They investigated this junction to see whether a pedestrian island could be placed there, but this is not feasible because the turning circle is not big enough for larger vehicles. They have also agreed for dropped kerbs to be installed at the school entrance at Marden Primary Academy in Goudhurst Road. These works will be funded by KCC out of their small works budget. Because of the issues with parked vehicles along Pattenden Lane, it is planned for yellow lines to be installed. An informal consultation was undertaken with residents and businesses of Pattenden Lane and Kent Highways are now reviewing these responses and a formal consultation will be advertised in the coming months for parking restriction proposals in this area.

Cateways to the entrance to
Chainhurst have also been added to
the HIP along with a gateway in
Maidstone Road. Following a
resident's request, double yellow lines
on the south side of Stanley Road
junction have also been added to the

Village Parking Enforcement

The Parish Council have been lobbying Maidstone Borough Council (MBC) regarding parking around the village especially near the school at drop off and pick up times along with other locations where restrictions are being ignored.

MBC has now agreed to an increase in enforcement patrols in Marden to help improve levels of driver compliance to the parking regulations in the area. Let's hope it has a positive effect.

Marden Railway Station

The Parish Council act on behalf of users of Marden Railway Station as it a valuable service for Marden and surrounding areas. We have had varying degrees of success holding meetings and now things have returned to normality, we are seeking a meeting with the station manager/Network Rail on a number of issues including upgrading the cycle rack facilities. We are also working jointly with our County Councillor to ensure that KCC are effective at lobbying for the best train service as possible.

From a sustainability point of view, we need to try to get as many people as possible off the roads and utilise the train service more. There's a lot of engineering works/strikes planned, so please check before you travel.

Kent County Council Bus Consultation – Bus Funding Reductions

KCC recently undertook a bus consultation proposing savings by reducing the money they spend on providing some bus services that private bus companies cannot afford to run and are no longer cost effective.

Fortunately, Marden's bus services are not currently on the list of services out for consultation for future savings, but we need to keep a watchful eye as already Marden has a very limited bus service. However, the number 5 bus which runs on the A229 and stops at the Stilebridge looks to be a route earmarked for a cut in subsidy. If residents have any comments/suggestions, we encourage you to raise with the relevant bus company or let the Parish Council know so we can act for the wider community.

KCC - Removing Private Trees from the Highways

The Winter storms served as a reminder that vulnerable and weak trees can cause significant damage and in some cases loss of life, additionally they can significantly impact how we are able to reliably use roads. KCC as landowners need to ensure their trees are properly managed to minimise the risk of failure with the associated consequences.

HIGHWAYS & PUBLIC TRANSPORT CONTD

KCC - Removing Private Trees from the Highways (Contd)

KCC are trialling a new process to recover costs associated with the clearing and removal of private trees that are obstructing the highway or are considered a risk to highway users. In the interest of public safety, KCC ask that owners or occupiers of land with trees near the highway have them regularly inspected by a competent person to meet their 'Duty of Care' and KCC as the Highway Authority also have a 'Duty of Care' under the Highways Act 1980 to ensure the free and safe passage for users of the highway. Where they need to remove trees that are blocking the highway or are an imminent risk to highway users, they will do so under their emergency procedures and may seek to recover all reasonable costs from the owner or occupier of the land. OPEN SPACE

After the Queen's Platinum Jubilee events in Southons Field and the recent Marden Motor Show, hopefully most residents now know of the existence of this beautiful, tranquil field which is dog free (with the exception of assistance dogs). Many thanks to Warren Porritt for donating and erecting a football goal in Southons Field.

POLICE & CRIME UPDATE

Maidstone Task Force have been very active in both Marden and Yalding recently with one Sergeant and four Police Officers in attendance and are working closely with the community. They are here to act on community issues that mean the most to us and want to hear from anybody who has information.

They conducted three Stop Searches on individuals suspected of being in possession of drugs. Cannabis was located and seized from two individuals and a crime recorded. In February, there were 2 burglaries, 3 criminal damages, 1 arson, 1 theft from motor vehicle and 2 attempted criminal damages. In March there was 1 burglary, 1 theft from motor vehicle and 1 attempted criminal damage. In April, there was a theft of an e-scooter but this was returned after local and Facebook enquiries. After a spate of fires in the Churchyard arrests were made and it is hoped that the culprits will receive restorative justice by helping to tidy up the Churchyard.

POLICE & CRIME UPDATE CONTD

It is an offence to carry Cannabis or to drive whilst under the influence of Cannabis and they will continue to implement stop and search in Marden to locate people carrying/using drugs and take them off the road to ensure a safer environment for all. If you have information about local crime that you think would be of interest to the Maidstone Task Force, or Ring doorbell footage or mobile pictures/footage of suspicious activity then please email: rebecca.burns@kent.police.uk. This includes theft/shoplifting/burglaries, assaults or violence, drug dealing or drug use, drink driving, no insurance driving.

Anti-Social Behaviour (ASB)

In March several reports were received of anti-social behaviour during half term week. On 12th April, there was a proactive patrol in the Marden area by Maidstone Police who teamed up with the British Transport Police for a 'Day of Action' to intercept anti-social behaviour which included assaults on trains between Marden and Paddock Wood and at the railway station. There were also reports of males with catapults and CCTV was viewed and males identified.



In May, there were several reports in Cascade Way and Challenger Way and both the Police and Medway Housing are working in partnership to deal with antisocial behaviour, nuisance motorbikes and drug activity around this area. Golding Homes have installed CCTV in several of their blocks of flats and are looking to work with the new Youth Worker once the Youth Club is up and running.

From aggressive, noisy or abusive behaviour to neighbourhood disturbances involving drugs or animals, antisocial behaviour takes many forms, and you should report all crimes and ASB to the Police. My Community Voice (MCV)

Maidstone Borough Council and Kent Police are keen for residents to use "My Community Voice" which builds processes that support residents. So, it's important that you use 'My Community Voice Kent' (MCV) to ensure issues are recorded and safeguarding issues can be monitored. MCV is a two-way engagement tool set up by Kent Police for residents, businesses and community groups in Kent and Medway. MCV will enable Kent Police to update users with news, alerts, appeals, engagement events and general policing activities. Members of the public can choose what information you receive and how you receive it, and you can also share or reply to messages.

MCV offers another avenue like
Neighbourhood Watch and the Parish
Council continues to welcome all
residents who have set up a
Neighbourhood Watch group and are
happy to place anything in the Parish
Newsletter if any group wishes to
provide information.

Cold Calling/Fraudsters

The Maidstone Task Force have been focusing more attention in the Marden area recently as there has been a crime trend in which fraudsters make cold calls and pretend to be the Police and ask members of the public to withdraw money. The Police would never ask for your bank details or Pin, as you to transfer money or handover cash sums or send a courier to collect your bank cards, cash or PIN. If any phone calls are made to you about this. please record the number and inform the Police via 101 or an online submission. You can also submit an Action Fraud report online.

DFCM hope to progress this further in building our inclusive community across all ages and any unseen barriers. Marden Medical Centre is working with DFCM (Charity Inc. Group) to give a newly diagnosed patient or family caring for someone with dementia envelopes which will include artwork from children in the village. We are also planning to produce a 2023 calendar with the children's artwork.



We organised a Virtual Dementia
Tour in Marden in partnership with
the Library in May. This was no
ordinary training session, and the
brave participants were asked to
complete various tasks whilst
wearing glasses that inhibit vision,
earphones that inhibit hearing and in
a dark space with someone
interrupting and intimidating them.

Afterwards they met in the library and listened to a talk which expanded on this experience with some very interesting information about dementia. Thirty two people from across the village completed this experience helping to raise awareness of the condition that so many are now living with.

After a lot of hard work, effort and trying to tick a big sustainability box, it is sad and disheartening to report a lot of them have been destroyed or died at Windsor Meadows, Highwood Green and The Parsonage open space areas and Appledown Grange attenuation pond area.



In early March, CIIr Anne Boswell along with Adrian & Diana Rabot and the Police Cadets planted 100 more saplings on the boundary in Southons field – a mix of Wild Cherry, Hazel, Blackthorn, Elders, Rowan, Dogrose and Crab Apple. A few saplings have also been donated to the school to plant in their new Jubilee Garden.

The Parish Council is hoping to plant a few trees at the Playing Field and Rookery Path in the Autumn to fill in gaps and help to create a wildlife corridor. Cllr Matt Besant is also hoping to apply for more saplings from the Woodland Trust to try and replace some of those that have been destroyed.

Marden EcoHub

The Marden EcoHub Facebook group was set up several years ago by Anna Fisk, a Marden resident. It aims to make Marden as green and sustainable as possible and to promote the 6Rs: rethink, refuse, reduce, reuse, repair, recycle.

We would like to congratulate Anna, a very enterprising lady, who set up a recycling hub collection point in Marden near the Chinese takeaway in Maidstone Road a year ago which has been a huge success. The collection point helps to raise money for various charities and reduces Marden's carbon footprint by reducing landfill. After a year Anna appealed for fund raising support, and Marden Village Club kindly provided new bins helping the system to continue to work well.

The hub currently collects: print cartridges, bras, old pens, reading glasses, ring pulls, cheese wrappers, egg boxes, stamps, toothbrush tubes and brushes, beauty product tubes, roll on...so far.

Marden Wildlife Update

Thanks to a KCC Covid recovery grant, we have purchased 75 commercially produced footpath signs to erect around the village. Each has a unique QR code to scan with your smart phone. It will take you to a MW website page describing what you are likely to see and hear on your walk along the path, and how the adjacent farmland is being managed for conservation. Our original 25 homemade signs have been replaced and more are being added as time permits.

Kent Wildlife Trust ecologist Dr Kirsty Swinnerton is working with members and landowners to study the local turtle dove population and how the birds use the area's hedgerows, fields and gardens. KCC Tree Strategy Consultation

The bulk of refuse waste goes through the efficient recycling plant at Aylesford. The recycled waste is hand sorted and every stage is scrutinised. Separation of different waste is undertaken in Maidstone and KCC has overall responsibility on waste management.

Recycled food waste is made into compost and sold to local farmers to plough back into the land. We know many of you already reduce your food waste by using a brown/orange food caddy and for those residents who don't, you can purchase one for £8 at: https://maidstone.gov.uk/home/primar y-services/bins-and-recycling/primary-areas/need-a-new-bin and is collected every week by placing alongside your other wheeled bin.



Please don't use plastic bags unless they are compostable, but can also be wrapped in newspaper. The average family wastes over £750 per year on food waste. So what can I place in my food caddy? Any raw or cooked food removed from its packaging.

YOUTH PROVISION

Kent County Council started to run a new Youth Club in the John Banks Hall on Thursdays but didn't have much attendance or success. Church Bells Appeal

The current peal of eight bells of Marden church has been an integral part of village life for over 100 years, ringing for Sunday services and pastoral offices, as well as national events of significance.

The current bells were installed in 1909 and have had no significant maintenance work done to them since then. Most of the fittings are wooden and in urgent need of replacing and updating and without this work the bells will cease to be 'ringable'.

The restoration would enable the bells to be easily rung by all age groups, especially children and older people. The project will cost £80,000 and they are hoping to have raised enough funds to complete the project in 2023 so the bells can ring for another 100 years!

Marden Primary Academy Update

It has nearly been a year since I took post at Marden Primary Academy and what a year it has been. We have a completely new curriculum here at Marden, teaching complex concepts transdisciplinary through the International Baccalaureate Primary Years Programme.

So, what does this actually mean? Well, this is really encapsulated in the EYFS where they were exploring the central idea: 'Shelter, for humans and animals, is a basic need.'
The children supported Trevor, our excellent site manager, in creating a shelter in the early years garden.

They carefully talked through their plans with Trevor, considering any difficulties before setting to work.
The children worked together brilliantly and demonstrated many of the learner profile attributes, which we actively work on as a school.

When the children learned that some people do not have a shelter and are in fact homeless, they wanted to help. Working collaboratively, the children planned a cafe for their parents. They made a video to explain their learning to the parents, wrote menus, made signs and sold cakes, biscuits and drinks to raise money for the charity, Shelter.

We are so proud of EYFS; they managed to raise a fantastic £245.95. A spokesperson from Shelter said, 'Amazing! What an incredible amount raised - we are blown away and so thankful!'.

We are also big believers in offering cocurricular activities, to broaden the horizons of our students ad provide a greater holistic education. This is a pressing issue for our village especially as various developments in Marden have raised over £1m \$106 money towards the cost of expansion plans/providing additional spaces at Marden Primary Academy. Maidstone Borough Council are the collection authority for \$106 and CIL monies and they are then passed to KCC or other providers for spending.

Both our County Councillor Lottie
Parfitt-Reid and Borough Councillor
Claudine Russell have been liaising
with our MP Helen Grant and putting
pressure on the Cabinet Member for
Educational Skills at KCC on how the
situation can be resolved.

Local Government Boundary Commission Review (LGBCE)

The Local Government Boundary
Commission has decided that the
number of Borough Councillors in

consultation on the borough's
boundary and responses are currently
being processed for submission to the
LGBCE. MBC had proposed that the
current Marden & Yalding Ward be
amalgamated with Hunton & Linton
Ward.

However, the Parish Council proposed in their response that Marden, Collier Street and Hunton become a ward with two Borough Councillors. The LGBCE will publish the Commission's recommendations by the 29th November 2022.
