

# **Accessibility Statement for Marden Parish Council**

This Accessibility Statement applies to www.mardenkent-pc.gov.uk

This website is run by Marden Parish Council. We want as many people as possible to be able to use this website. For example, that means you should be able to:

- zoom in up to 300% without the text spilling off the screen
- navigate most of the website using just a keyboard
- navigate most of the website using speech recognition software
- listen to most of the website using a screen reader

We have also made the website text as simple as possible to understand.

AbilityNet (<u>www.abilitynet.org.uk</u>) has advice on making your device easier to use if you have a disability.

# How accessible is this website?

We know some parts of this website are not fully accessible:

- you cannot modify the line height or spacing of text
- some PDF documents are not fully accessible to screen reader software
- you cannot skip to the main content when using a screen reader
- some of our online forms are difficult to navigate using just a keyboard
- some documents are not fully accessible as these are from a third party and cannot be modified

#### **Compliance Statement**

This website is currently partially compliant with the Web Content Accessibility Guidelines version 2.1 AA standard, due to the non-compliances listed below.

## Non-accessible content

There may be pages with read more / click here links. See WCAG 2.4 Success Criterion 4.4 (Link Purpose (In Context)

There may be some pages where HTML is not perfectly formed, such as stray end tags. See WCAG 2.1 success criterion 4.1.1 (Parsing).

Many of our older PDFs and Word documents do not meet accessibility standards - for example, they may not be structured so they're accessible to a screen reader. See WCAG 2.1 success criterion 4.1.2 (name, role value).

Some images on the website pages may not have a text alternative, so the information on them is not available to people using a screen reader. See WCAG 2.1 success criterion 1.1.1 (non-text content). We continue to manage the website and and when we publish new content, we will endeavour to make sure our use of images meets accessibility standards.

#### Navigation and accessing information

You may experience problems using the tab key in the page header as it skips back to Home after each page is reviewed.

It is not always possible to use the keyboard to view documents listed on pages.

# Interactive tools and transactions

We have assessed the cost of fixing issues with navigation and accessing information, and with interactive tools and transactions. We believe that doing so now would be a disproportionate burden within the meaning of the accessibility regulations.

#### PDFs and other documents

Some of our PDFs, Word and Excel documents are essential to providing our services. For example, we have forms published on Word and spreadsheets/tables on Excel. We plan to review and if possible replace these if possible.

Any Word, Excel or PDF documents published before 23<sup>rd</sup> September 2018 which are not essential to providing our services are not required to meet accessibility standards.

Any new PDFs, Word of Excel documents we publish we will endeavour to meet accessibility standards.

## How we tested this website

This website was tested both manually and automatically prior to the writing of this statement and will be reviewed periodically.
