- (b) 16/504263/FULL Bumpers Hall, Maidstone Road

Relocation of existing vehicular access

The member of the public wished to point out details of relocation of vehicular access to existing and proposed property

On the basis of there being no inappropriate gates being proposed the Cllrs recommended support of this application.

(a) 16/503706/FULL - 12 Napoleon Drive

Erection of a single storey rear extension

After viewing the documents Cllrs had no objection but wished the applicants to acknowledge that the tree is protected by a TPO and that this will limit the amount of arboricultural work in the future.

(c) 16/504889/TCA – Bowling Green Cottage, High Street

Conservation area notification to 1 no. Copper Beech – crown reduction of 30%, 1 no. Pussy Willow – crown reduction of 30%, 1 no. Silver Birch – crown reduction of 30% Cllrs have no objection providing that the cutback is no more than the minimum as MBC's Tree Officer feels appropriate.



(d) 16/504532/LAWPRO - 20 The Old Market

Lawful Development Certificate (proposed) for loft conversion with 3 no. Velux windows to front elevation and 2 no. to rear elevation

Although the Parish Council was not consulted on this application the Assistant Clerk had provided details of this to the attention of Cllrs. The Cllrs had no objection provided that it did not conflict with any withdrawal of permitted development rights in the conditions attached to the original application.
